

ORDINANCE 21-01-02

AN ORDINANCE FOR AMENDING ORDINANCE 20-05-01 SCHEDULE OF WATER SERVICE FEES FOR THE VILLAGE OF SHERWOOD, OHIO.

WHEREAS, the Council of the Village of Sherwood deems it necessary to have a schedule of fees for the water service;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL, of the Village of Sherwood, State of Ohio, as follows:

SHUT-OFF (REGULAR SERVICE HOURS)	\$30.00	9 AM - 3 PM, EXCLUDES HOLIDAYS AND WEEKENDS INCLUDES COST OF RECONNECTION
AFTER HOURS SHUT-OFF	\$200.00	HOLIDAYS AND WEEKENDS, INCLUDES COST OF RECONNECTION DURING REGULAR SERVICE HOURS*
WATER NOTICE DELIVERY	\$20.00	FOR NON-PAYMENT AND DELINQUENT BALANCES
SHUT OFF DUE TO DELINQUENT ACCOUNT BALANCE	\$50.00	WATER SERVICE WILL BE REINSTATED DURING REGULAR SERVICE HOURS AFTER PAYMENT IS MADE
DEPOSIT	\$100.00	\$50 WATER/\$50 SEWER - DEPOSIT WILL BE CREDITED TOWARD ANY OUTSTANDING BALANCE IF SERVICE IS TERMINATED
TAMPERING WITH METERS	\$300	WILL BE APPLIED TO UTILITY BILL
DAMAGED METERS	\$300	PLUS, COST OF REPLACEMENT/REPAIR OF METERING COMPONENTS (NEEDS TO BE PAID BEFORE WATER SERVICE IS REINSTATED)
DATA READ	\$30	WILL BE CREDITED IF ISSUE IS DISCOVERED WITH METER
RESIDENT REQUESTED METER CHANGE OUT	\$200	LABOR CHARGE ONLY (DOES NOT INCLUDE THE COST FOR CALIBRATION, METER, SHIPPING, ETC.) CALIBRATION MUST BE DONE FOR EVERY METER CHANGE OUT
¾ METER	\$275	
1-INCH METER	\$335	
>1-INCH METER		AT COST TO RESIDENT
*AN ADDITIONAL \$100 CHARGE WILL BE INCURRED IF WATER IS TO BE TURNED ON AFTER REGULAR SERVICE HOURS		

Wherefore, THIS Ordinance shall be in full force and effect at the earliest time permitted by law and repeals any ordinance or resolutions in this matter.
