ORDINANCE 22-01-01

AN ORDINANCE TO MAKE PERMANENT APPROPRIATIONS FOR THE CURRENT YEARS EXPENSES AND OTHER EXPENDITURES OF THE VILLAGE OF SHERWOOD VILLAGE

Now, Therefore, be it resolved by the Council of the Village of Sherwood, State of Ohio, the following:

Section 1. That the Temporary Appropriation Ordinance (Ordinance 21-12-02) is hereby amended and this Ordinance becomes the Permanent Appropriation Ordinance for 2022 to make appropriations for current expenses and other expenditures of the Village of Sherwood, State of Ohio, during the fiscal year ending December 31, 2022 the following sums be and they are hereby set aside and appropriated as follows, viz:

Section 2. That the Village Fiscal Officer is hereby authorized to make payments from any of the foregoing appropriations and to make supplemental appropriations within the same "Fund" and "Program" area as provided by the Ohio Revised Code (ORC)

Section 3. That the Village Council authorizes that funds may be expended for coffee, meals, refreshments and/or other amenities for municipal officers, employees and other persons.

Section 4. That there be appropriated from the GENERAL FUND for contingencies for the purposes not otherwise provided for, to be expended in accordance with the provisions of

And the Village Fiscal officer is hereby authorized to draw warrants on the Village treasury for payments from any of the foregoing appropriations upon receiving proper certificates and vouchers therefore, approved by the board of officers authorized by law to approve the same, or an ordinance or resolution of council to make the expenditures: provided that no warrants shall be drawn or paid for salaries or wages except to persons employed by authority of and in accordance with law or ordinance. Providing further that the appropriations for contingencies can only by expended upon appeal of twothirds vote of council for items of expense constituting a legal obligation against the Village, and for purposes other than those covered by other specific appropriations herein made.

Section 8. That this ordinance is hereby declared an emergency measure necessary for the preservation of public peace, health and safety of the Village and its inhabitants for the reason that there exists an imperative necessity for the earliest passage of this Ordinance to meet the fiscal obligations and it shall take effect at the earliest period allowed by law.

Section 5705.39, R.C. - "No appropriation measure shall become effective until county auditor files with the appropriate authority... a certificate that the total appropriations from each fund, taken together with all other outstanding appropriations, do not exceed such official estimate of amended official estimate. When appropriation does not exceed such official estimate, the county auditor shall give such certificate forthwith upon receiving from the appropriating authority a certified copy of the appropriation measure..."
